(1) On February 23, 2017, 2,128 restricted shares of Mr. Foust's Company stock, granted March 9, 2015, vested. On February 23, 2017, Mr. Foust automatically surrendered 1,073 of the 2,128 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.

(2) On February 23, 2017, 4,173 restricted shares of Mr. Foust's Company stock, earned February 15, 2016, vested. On February 23, 2017, Mr. Foust automatically surrendered 2,103 of the 4,173 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 23rd vesting.
