Item 1.01 Entry into a Material Definitive Agreement.

On September 6, 2006, the Registrant and National Financial Communications Corp. (the “Consultant”) amended an existing consulting agreement dated as of May 1, 2006 (the “Consulting Agreement”, as amended, the “Amendment”). Pursuant to the Amendment, the Consultant will not receive stock compensation as consideration for services rendered under the Consulting Agreement. Rather, the Consultant will receive a cash sum of \$2500 per month. The Consulting Agreement is otherwise unchanged.

No stock was issued to the Consultant as compensation under the Consulting Agreement.
