- (1) Between April 3, 2007 and July 3, 2007, the Reporting Person acquired 21 shares of DRE common stock through dividend reinvestment.
- (2) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/31/06.
- (3) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/30/07.
- (4) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/29/08.
- (5) The Stock Options vest annually at a rate of 20% per year and will be fully vested on 1/28/09.

(6) Represents phantom stock units accrued under the Director's Deferred Compensation Plan of Duke Realty Corporation. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer.
