- (5) Each restricted stock unit represents a contingent right to receive one share of Issuer common stock.

- (6) The reporting person was awarded performance units in 2014 covering a three-year performance period ending December 31, 2016. The reporting person previously reported the minimum number of units subject to the award eligible to vest based on 2014 and 2015 performance. The number of units reported reflects the additional minimum number of units eligible to vest as a result of the crediting of restricted stock units in respect of dividend equivalent rights. The units remain subject to additional time-based vesting requirements.

- (7) The reporting person was awarded performance units in 2015 covering a three-year performance period ending December 31, 2017.
