The holdings are net of shares previously sold under a Rule 10b5-1 trading plan to cover withholding taxes.
- On October 23, 2006, the Company granted 50,000 restricted shares under the Company's Management Long Term Incentive Program, (2) all of which will cliff vest in February 2010, subject to accelerated vesting in equal thirds in February of each of 2008, 2009 and 2010, if certain performance targets are met.
