Marx and Greenhouse are also members of MG Advisers L.L.C. (MG), the general partner of and investment adviser to Special Situations Private Equity Fund, L.P. (SSPE). (SSF3, Cayman and SSPE will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

(b) Percent of Class: Messrs. Marx and Greenhouse beneficially own 16.8% of the shares outstanding. Cayman owns 2.0% of the outstanding shares, SSPE owns 7.4% of the outstanding shares and SSF3 owns 7.9% of the outstanding shares.
