Represents the maximum number of shares that will be earned, if at all, based on the Issuer's relative shareholder return from January 26, 2015 through January 28, 2018. Each restricted stock unit represents a contingent right to receive one share of Issuer's common stock.

- (4) The maximum number represents 200% of the target payout of 6,000 shares. If a pre-established threshold is achieved, the shares earned will vest as to 100% on March 21, 2018, such that the shares are fully vested on approximately the three (3) year anniversary of the date of grant.
- (5) Includes 1,618 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on February 27, 2015 and 41,175 shares issued upon the vesting of restricted stock units previously reported on a Form 4.
