ITEM 1. DESCRIPTION OF REGISTRANT'S SECURITIES TO BE REGISTERED

The securities of Duke Realty Corporation (the "Registrant") to be registered on the New York Stock Exchange are 4,000,000 Depositary Shares (the "Depositary Shares"), each representing 1/10th of a 6.625% Series J Cumulative Redeemable Preferred Share, \$0.01 par value, \$250.00 liquidation preference (collectively, the "Series J Preferred Shares"), of the Registrant. A description of the Depositary Shares and the Series J Preferred Shares is set forth under the caption "Description of the Series J Preferred Shares and Depositary Shares" on pages S-6 through S-10 of the prospectus supplement dated July 24, 2003, which prospectus supplement was filed on July 28, 2003 by the Registrant pursuant to Rule 424(b) under the Securities Act of 1933, as amended, and made a part of the Registrant's Registration Statement on Form S-3 (Registration No. 333-37920). Such description shall be deemed to be incorporated by reference in this Registration Statement.
