Accordingly, on March 13, 2007, the date the stock dividend was paid, the option became exercisable for 157,500 shares at an exercise price of \$14.23 per share.

- (3) This option was previously reported as an option for 98,707 shares of common stock at an exercise price of \$32.62 per share but was adjusted to reflect WCI's 3-for-2 stock splits in the form of 50% stock dividends effective June 24, 2004 and March 13, 2007. Accordingly, on March 13, 2007, the date the stock dividend was paid, the option became exercisable for 148,062 shares at an exercise price of \$14.50 per share.
