On August 14, 2001, NeoTherapeutics, Inc. ("NeoTherapeutics") issued 600,000 shares of common stock to an institutional investor for aggregate consideration of \$2,010,000. The shares were issued pursuant to an effective Registration Statement on Form S-3. The negotiated purchase price per share was \$3.35.
