The Registrant is unable to file its Annual Report on Form 10-K for the year ended December 30, 2005 by the prescribed date due to unanticipated delays in completing its final close processes related to satisfying the requirement to reflect the discontinuation of its operations in Latin America. The Registrant anticipates that the financial statements will be completed in sufficient time to allow for the filing of its Annual Report on Form 10-K on or before March 30, 2006.

In December 2005, the Registrant made the decision to exit the Company's Mexican operations and certain of its other deployment businesses in South America. Prior to this decision, these operations had been reported in its Wireless Network Services segment. The Registrant determined that these operations meet the criteria to be classified as held for sale. Accordingly, Registrant intends to reflect these operations as discontinued in accordance with SFAS No. 144, Accounting for the Impairment or Disposal of Long-Lived Assets. The South American operations were substantially shut-down as of the end of December 2005. Registrant disclosed its operating results on March 14, 2006.
