(1) On October 10, 2008, TRT Holdings, Inc. ("TRT") purchased 177,640 shares of the common stock of Gaylord Entertainment Company ("GEC") in 1198 open market purchases, at prices ranging from \$16.65 to \$17.50 per share, and with a weighted-average per-share price of \$17.2430. TRT agrees to provide, upon request by the Securities Exchange Commission, GEC, or a holder of the common stock of GEC, full information regarding the number of shares purchased at each separate price.

(2) The reported securities are owned directly by TRT. Robert B. Rowling indirectly beneficially owns the reported securities due to his ownership of all of the Class B shares of Common Stock of TRT.
