### EXPLANATORY NOTE

This Amendment No. 12 to Schedule 13D (Amendment) relates to the Common Shares of Beneficial Interest without par value (the Common Shares) of Western Asset/Claymore Inflation-Linked Securities & Income Fund (the Issuer). This Amendment is filed to amend and supplement the Items set forth below of the Reporting Persons Schedule 13D previously filed with the Securities and Exchange Commission on January 3, 2006, as amended on April 19, 2006, June 19, 2008, July 7, 2008, July 17, 2008, October 17, 2008, October 15, 2010, September 12, 2012, April 21, 2014, December 12, 2014, December 15, 2014, and December 24, 2014.

### Item 3. Source and Amount of Funds or Other Consideration

Since the event requiring its most recent Schedule 13D filing, Cascade purchased 516,547 Common Shares with its working capital for an aggregate purchase price of \$6,051,540.57. Cascade also acquired 15,056 Common Shares pursuant to a dividend reinvestment plan of the Issuer. Other than the reinvestment of the dividends, Cascade paid no consideration to acquire these shares.
