**EXPLANATORY STATEMENT**

This Amendment No. 12 to Schedule 13D ( Amendment ) amends and supplements the Schedule 13D previously filed by Cascade Investment, L.L.C. ( Cascade ), Bill & Melinda Gates Foundation Trust (the Trust ), William H. Gates III and Melinda French Gates (together with Cascade and the Trust, the Reporting Persons ) with the Securities and Exchange Commission on February 5, 2009, as amended February 6, 2009, February 24, 2010, July 23, 2010, August 17, 2010, February 2, 2011, November 4, 2011, November 14, 2011, December 2, 2011, February 17, 2012, March 26, 2012, and May 22, 2012, relating to the Common Stock, Par Value \$0.01 per share (the Common Stock ) of AutoNation, Inc. (the Issuer ). Neither the present filing nor anything contained herein shall be construed as an admission that the Reporting Persons constitute a group for any purpose and each Reporting Person expressly disclaims membership in a group. This Amendment is being filed due an increase in the percentage of the Reporting Person s ownership resulting from a decrease in the Issuer s outstanding shares of Common Stock, and not as a result of any recent acquisitions by the Reporting Persons.

In June 2012, Cascade purchased 61,884 shares of Common Stock of the Issuer with its working capital for an aggregate purchase price of \$2,167,823.83.
