(a) Amount beneficially owned:

As of December 31, 2015, the Steven K. Conine 2007 Irrevocable Trust owned 1,460,477 shares of Class B common stock and the Steven K. Conine 2007 Non Exempt Irrevocable Trust owned 2,561,852 shares of Class B common stock. The Reporting Person is trustee for these trusts, and in that role the Reporting Person exercises voting and investment power over the shares. Each share of Class B common stock is convertible at any time at the option of the Reporting Person into one share of Class A Common. In addition, each share of Class B Common Stock will automatically convert into one share of Class A Common Stock (a) upon transfer thereof, subject to certain exceptions, (b) upon the date on which the outstanding shares of Class B Common Stock represent less than 10% of the aggregate number of shares of the then outstanding Class A Common Stock and Class B Common Stock, or (c) in the event that holders of at least 66²/₃% of the then outstanding shares of Class B Common Stock elect to convert all shares of Class B Common Stock into shares of Class A Common Stock.

The ownership percentage above is based on an aggregate of 49,836,566 shares of Class A Common Stock outstanding, consisting of (i) 45,814,237 shares of Class A Common Stock outstanding as of December 31, 2015, and (ii) 4,022,329 shares of Class A Common Stock issuable upon conversion on a one-for-one basis of 4,022,329 shares of Class B common stock owned by the trusts as of December 31, 2015.
