### Clarification on Dividends for fiscal year 2002

---

(Rio de Janeiro, February 18, 2003). PETROLEO BRASILEIRO S.A Petrobras, (BOVESPA: PETR3 / PETR4, NYSE: PBR / PBRA, LATIBEX: XPBR / XPBRA), Brazil's largest oil and gas, petrochemicals and energy company, wishes to provide more details on the information contained in the press release on February 17, 2003 with respect to dividends and interest on capital for the fiscal year 2002.

Pursuant to Article 9, Sole Paragraph of the Company's Bylaws, we confirm that both dividends and Interest on Capital will be monetarily restated at the SELIC rate as from December 31, 2002 to the initial date for payment. Only Interest on Capital is subject to withholding tax of 15%, except for those shareholders either immune to or exempt from withholding tax.
