- (1) On April 25, 2006, each of Boyd -05 Grantor Retained Annuity Trust #1, Boyd -05 Grantor Retained Annuity Trust #2 and Boyd -05 Grantor Retained Annuity Trust #3 distributed the reported number of shares to its beneficiary.
  - (2) On April 25, 2006, BG-05 Limited Partnership distributed an aggregate of 1,706 shares to its limited partners (the "BG-05 Distribution"). The reporting person no longer has investment control over 634 of the shares distributed.  
  
In connection with the BG-05 Distribution, the reporting person distributed 1,054 shares to the Marianne Boyd Johnson-05 Western Grantor Retained Annuity Trust #1 and 18 shares to The Marianne E. Boyd Trust.
