(1) Represents the payout of a Performance Share Award for the Fiscal 2009 to Fiscal 2011 Performance Period under The Toro Company Performance Share Plan (the "PSP"), as approved by the registrant's Compensation & Human Resources Committee of its Board of Directors and conditioned upon and subject to confirmation by the registrant's Fiscal 2011 financial results released on December 6, 2011. Performance Share Awards are paid in shares of common stock under the PSP.

(2) Includes 2,000 shares of restricted stock awarded to the reporting person, and 14,290 shares acquired under The Toro Company Dividend Reinvestment Plan (the "DRIP") from dividends paid on the restricted stock since the date of his last report. The restricted stock and related DRIP shares vest in full on the third anniversary of the date of grant, which was March 30, 2011.
