Awards of restricted stock units ("RSUs") which represent a hypothetical interest in Carnival plc ordinary shares, which will vest on the third anniversary of the grant date. The awards represented in this total are as follows: 3,261 RSUs awarded on February 15, 2012; 2,545 RSUs awarded on January 15, 2013; and 3,288 RSUs awarded on January 14, 2014. The RSUs will accumulate dividend equivalents and may only be settled in shares.
- (2) The grant was approved by the Compensation Committee as a total value to be received in the form of RSUs. The Compensation Committee also approved that the number of shares was to be determined by taking the value and dividing by the closing price of Carnival plc ordinary shares on the grant date.
