- (1) Each restricted stock unit represents a contingent right to receive one share of MDR comon stock.

Each restricted stock unit represents a contingent right to receive the value of one share of MDR common stock, with such restricted stock units to be paid, in the sole discretion of the Compensation Committee: (i) in shares of MDR common stock, (ii) cash equal to the fair market value of the shares of MDR common stock otherwise deliverable, or (iii) any combination thereof.
 - (3) On March 5, 2015, the reporting person was granted 41,541 restricted stock units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
 - (4) On March 6, 2014, the reporting person was granted 25,509 restricted stock units, vesting in three equal annual installments beginning on the first anniversary of the grant date.
