On February 22, 2017 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 8,178 restricted shares of First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 22, 2019, 4,089 of the originally granted RSAs vested, of which 1,373 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations.
