**CHANGE OF JURISDICTION TO ONTARIO**

**SUBSIDIARY GFT ENTERTAINMENT INC. CHANGES NAME TO**

**PEACE ARCH MOTION PICTURES INC.**

**TORONTO, ONT.** Peace Arch Entertainment Group Inc. (AMEX and TSX: PAE ), a diversified Canadian entertainment company, today announced that the Company has formally changed its governing jurisdiction to the Province of Ontario from the Province of British Columbia.

The Company has been a British Columbia company since it was incorporated in 1986.

The Company's conversion to an Ontario corporation became effective on September 1, 2004. It was authorized at the Company's Annual Meeting in February, 2004.

The Company considers that becoming an Ontario corporation recognizes that the center of its operations has shifted to Toronto from Vancouver.

The Company believes that the change of its governing jurisdiction will have no material impact on the Company, its activities, or its stakeholders.

The Company would also like to announce that its subsidiary GFT Entertainment Inc. has changed its name to Peace Arch Motion Pictures Inc. effective September 1, 2004. The Company has also incorporated a new subsidiary, Peace Arch Television Ltd., which will hold the Company's interests in its television and documentary subsidiary, The Eyes Project Development as well as manage worldwide licensing of television distribution rights owned by the Company. The incorporation of Peace Arch Television Ltd., and name change to Peace Arch Motion Pictures Inc. furthers the goal of the Company to promote all operations under the brand name of Peace Arch.
