#### PEACE ARCH ANNOUNCES REQUIRED CHANGE TO ITS BOARD OF DIRECTORS

Toronto November 26, 2007 Peace Arch Entertainment Group Inc. (AMEX:PAE - News) (TSX:PAE.TO - News), an integrated global entertainment company creating and acquiring critically acclaimed film, television and DVD content for worldwide distribution, announced today that Ms. Mara Di Pasquale, the Company's Chief Financial Officer has resigned as a director of the Company. Ms. Di Pasquale's resignation from the Board was prompted by the appointment of Jeff Sagansky as Interim Chief Executive Officer on November 6, 2007. As a result of Mr. Sagansky's appointment as Interim Chief Executive Officer, he ceased to be an independent director of the Company. In order for the Company to continue to meet AMEX and OSC guidelines which require that a majority of the board members be independent, one of the non-independent directors was required to resign. Ms. Di Pasquale will continue in her role as Chief Financial Officer of the Company and will still play a meaningful role as an observer on the board.

Accordingly, the directors of the Company consist of Messrs. Drew Craig, Ian Fodie, Robert Essery and Ms. Juliet Jones, each of whom is considered to be an independent director and Messrs. Jeff Sagansky, Richard Watson and John Flock each of whom are considered to be non-independent directors. The Board intends in due course to seek out another suitable independent candidate for the Board so that at the appropriate time Ms. Di Pasquale can seek re-appointment to the Board.
