(1) A total of 6,000 shares were sold pursuant to a 10b-5-1 Plan at an average sale price of \$6.034833 per share. The actual sale price for the shares was: 500 shares at \$6.10; 500 shares at \$6.08; 1,000 shares at \$6.06; 2,300 shares at \$6.00; 1,200 shares at \$6.03; 200 shares at \$6.04; 300 shares at \$6.05.

(2) The options are exercisable as they vest.
