("Elliott Associates") through The Liverpool Limited Partnership, its wholly-owned subsidiary ("Liverpool"). Elliott Associates directly owns 1,747,100 shares of common stock and indirectly owns 1,713,181 shares through Liverpool. The shares held in Liverpool were previously held directly by Elliott Associates.
- (2) Elliott Associates also indirectly owns \$24,516,000 in principal amount of the issuer's 2-3/8% Convertible Bonds due May 15, 2017 through Liverpool.
