  - On July 23, 2012, the Compensation Committee of the Board of Directors of the issuer determined that 10,874 shares of the issuer's common stock had been earned by the reporting person under the terms of a grant of performance share awards (the "PSAs"), based on the achievement of specific performance criteria that were not tied solely to the market price of the issuer's common stock. The PSAs
