- (1) On January 4, 2017, the Issuer entered into an agreement with Kevin J. Bannon (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 1,050 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 5,050 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 3, 2017, restrictions applicable to a previously reported grant of 950 shares of Class A Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares.
- (3) The Reporting Person is the direct beneficial owner of 30,500 shares of Class A Common Stock, which includes the 5,050 restricted shares of Class A Common Stock referenced in Footnote (2) and 1,700 shares held in the name of the Kevin J. Bannon IRA for the benefit of Kevin J. Bannon.
- (4) The Reporting Person is the indirect beneficial owner of 1,500 shares of Class A Common Stock, of which 500 shares are owned by the Katherine E. Bannon 2001 Revocable Trust dated 10/22/01, for the benefit of Katherine E. Bannon, Mr. Bannon's daughter, and 1,000 shares are owned by the Trust established under the will of Nathan B. Epstein for the benefit of Susan E. Bannon, Mr. Bannon's wife, et ano. Mr. Bannon is co-trustee of each of the above-mentioned trusts.
