For the year ended December 31, 2005, the registrant currently estimates that it had revenues of approximately \$40,400,000 and a net loss of approximately \$2,400,000. Results for the 2005 fiscal year remain subject to further adjustment and actual results may differ significantly from the foregoing estimates. The main reasons for this increase in revenues from the year ended December 31, 2004 to the year ended December 31, 2005 can be attributed to various acquisitions.
