On November 3, 2006, the Issuer adjusted the conversion price from \$1.00 to \$0.50 on the Subordinated Secured Promissory Note due August 2, 2009 (the "Note") held by Crestview in the principal amount of \$2,000,000. Such adjustment of the conversion price occurred pursuant to the terms of the Note and Crestview paid no new consideration in connection with such adjustment. As a result of such adjustment, Crestview's beneficial ownership of the shares of Common Stock underlying the Note increased from 2,000,000 to 4,000,000.
