(a) Name of Issuer: ADVENTRX Pharmaceuticals, Inc. (the "Issuer").

(a) Name of Person Filing: This joint statement on Schedule 13G is being filed by Peter Kolchinsky, RA Capital Management, LLC, and RA Capital Healthcare Fund, L.P., who are collectively referred to herein as the "Reporting Persons." Mr. Kolchinsky (the "Manager") is the manager of RA Capital Management, LLC ("Capital"), which is the investment adviser and sole general partner of RA Capital Healthcare Fund, L.P. ("Fund") and serves as the investment adviser to a separate discretionary account. The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

(c) Citizenship: Capital is a Massachusetts limited liability company. The Fund is a Delaware limited partnership. The Manager is a United States citizen.

In the aggregate, the Reporting Persons beneficially own 2,365,000 shares of the Common Stock of the Issuer, representing approximately 9.9% of such class of securities. The Reporting Persons have the right to purchase an additional 591,250 shares of Common Stock pursuant to the terms of common stock purchase warrants issued on January 6, 2011, which are not exercisable except upon sixty-one (61) days prior written notice to the Issuer.

The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 1,182,500 shares of Common Stock representing approximately 5.0% of the class and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 2,365,000 shares of Common Stock of the Issuer representing approximately 9.9% of the class. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 23,664,858 shares of Common Stock of the
