(1) Convertible Secured Subordinated Note, due November 14, 2013 (the "Note")

- (2) prices of the Issuer's common stock on the OTCBB averaged over the 5 trading days prior to the closing date of the Note's issuance, (b) if the Issuer's common stock is not traded on the Over-The Counter market, the closing price of the common stock reported on the principal exchange on which the common stock is listed, averaged over the 5 trading days prior to the closing date of the Note's issuance, or
- (c) the closing price of the Issuer's common stock on the OTCBB or the principal exchange on which the common stock is listed, as
- (3) applicable, on the trading day preceding the date such Note is converted, in each case as adjusted for stock splits, dividends or combinations, recapitalizations or similar events.
