(the "Company") hereby announces the results of the Annual General Meeting of shareholders of the Company, held today, Thursday, August 3, 2017, in Bnei Brak, Israel (the "Meeting"). At the Meeting, all the proposals set forth in Company's announcement dated June 22, 2017, sent in connection with the Meeting were approved by the required majority of shareholders. The resolutions were as follows:

To approve the re-appointment of Kesselman & Kesselman, Israel CPAs, a member firm of PricewaterhouseCoopers International Limited, as the Company's independent registered public accounting firm for the year ending December 31, 2017 and until our next annual general meeting of shareholders, and to authorize the Company's Board of Directors to fix such accounting firm's annual compensation.

To elect Messrs. Alexander Rabinovitch, Dr. Jonathan Schapiro, Shlomo Shalev, Doron Turgeman and Dr. 2. Dobroslav Melamed to hold office as directors in the Company, commencing on the date of the Meeting and until the next Annual General Meeting of Shareholders.

To approve increase of the Company's authorized share capital by NIS 75,000,000, such that following the increase, 3.the Company's authorized share capital shall equal NIS 145,000,000 divided into 1,450,000,000 ordinary shares, par value NIS 0.1 each, and to amend the Company's articles of association accordingly.

- 4. To approve the new employment terms of Mr. Joshua Levine, the Company's Chief Executive Officer, including issuance of 1,000,000 options to purchase ordinary shares of the Company available through the Company's ESOP.
- 5. To approve new Compensation Policy, in accordance with the requirements of the Israeli Companies Law 5.759-1999, for a period of three years.
