 - (1) Cashless stock option exercise for 25,000 share options granted on 11/26/2001 at the option price of \$66.62 per share with tax withholding rights. Immediate sale through broker of the options. All shares were currently exercisable and would have expired 10 years from the date of grant.

- (5) 12,266.37 original deferral of phantom restricted shares (Special Retention Program) awarded under the 1998 Whirlpool Corporation Omnibus Stock and Incentive Plan in transactions exempt under Rule 16(b)-3(c). Dividend equivalents on deferred stock will be invested in additional stock.
- (8) 25,000 phantom stock shares (Career Stock Award) awarded under the 1996 Omnibus Stock and Incentive Plan in transactions exempt under Rule 16(b)-3(c). Phantom shares will become vested as follows: 10,000 shares on 11/26/06; 10,000 shares on 11/26/10; and 5,000 shares on retirement after age 60. As of 09/15/05, the latest date for which information is reasonably available, 27,455.65 total phantom shares deferred, which includes dividend equivalents earned in phantom restricted stock.
