(1) The option reported on Form 3 on April 23, 2007 inadvertently aggregated this option with the option referenced in footnote 2, granted to the reporting person on the same date. This option (100,000) will fully vest and become exercisable over a period of five years, with 50% of the option vesting and becoming exercisable half way through the relevant vesting period and the remainder vesting and becoming exercisable proportionately on each anniversary of the date of grant of the option occurring after the initial 50% vesting date.

(2) The option reported on Form 3 on April 23, 2007 inadvertently aggregated this option with the option referenced in footnote 1, granted to the reporting person on the same date. This option (50,000) will fully vest and become exercisable over a period of seven years, with 50% of the option vesting and becoming exercisable half way through the relevant vesting period and remainder vesting and becoming exercisable proportionately on each anniversary of the date of grant of the option occurring after the initial 50% vesting date.
