- (1) Grant of stock under the Issuer's 2011 Equity Incentive Plan in connection with the Reporting Person's services as a director.  
The aggregate dollar value of the annual equity award to each director in 2015-2016 shall be \$220,000, with one quarter of that amount in stock, or \$55,500, to be granted on the first day of each quarter based on the closing price of the Issuer's common stock on the last day of the immediately preceding quarter. The closing price of the Issuer's common stock on the last day of the immediately preceding quarter, December 31, 2015, was \$60.13. Thus, the grant this quarter for services as a director is for 915 shares of the Issuer's common stock.
- (2) Represents the closing price of the Issuer's common stock on December 31, 2015.
- (3) The total amount shown corrects an earlier overstatement of 3,225 shares.
- (5) 10,000 options are vested; the remaining 5,000 options will vest on March 11, 2016.
