Item 7.01. Regulation FD Disclosure

On April 15, 2005, Casey's General Stores, Inc. (NASDAQ: CASY) reported March 2005 same-store sales results. Average gasoline gallons sold per store increased 7.7% in March 2005 compared to March 2004. The average retail price of gasoline sold during March 2005 was \$2.02 per gallon. Same-store sales of grocery and other merchandise increased 6% and prepared food and fountain same-store sales increased 9.1% in March 2005 compared to March 2004.
