- (1) The entities directly acquiring the shares reported on this form are SPO Partners II, L.P. ("SPO Partners"), which bought 20,000 shares and William E. Oberndorf ("WEO"), who bought 500 shares. The range of prices for the purchases on 7/21/08, reported in Line 1 above, was \$34.09 - \$34.25. (full detailed information regarding the shares purchased at each price will be provided upon request).
- Due to the purchases causing this filing and related filings today, 17,902,984 shares of the issuer's common stock are owned directly by SPO Partners II, L.P. ("SPO Partners"), and may be deemed to be indirectly beneficially owned by (i) SPO Advisory Partners, L.P. ("SPO Advisory"), the sole general partner of SPO Partners, (ii) SPO Advisory Corp. ("SPO Corp."), the sole general partner of SPO Advisory, and (iii) John H. Scully ("JHS"), WEO, and William J. Patterson ("WJP"), the three controlling persons of SPO Corp.
- (2) Additionally, 735,730 shares of the issuer's common stock are owned directly by SF Partners, and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P. ("SF Advisory"), the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO & WJP, the three controlling persons of SPO Corp.
- (3) Additionally, as a result of the purchases causing this filing and related filings today, WEO owns 84,600 shares in his IRA, which is self-directed. Additionally, JHS owns 18,700 shares in his IRAs, which are self directed and WJP owns 1,700 shares in his IRA, which is self-directed.
