- (1) Prior to the beginning of the year the reporting person elected to receive common stock in lieu of cash for a portion of their annual retainer, which retainer is paid in quarterly installments.  
 Of the total shares ABS Capital Partners IV, LP owns 3,728,057 shares, ABS Capital Partners IV-A, LP owns 124,825, ABS Capital IV Offshore, LP owns 214,103, ABS Capital IV Special Offshore, LP owns 145,967 shares (collectively, the ?Funds?), and Timothy T. Weglicki directly owns 8,408 shares and indirectly owns 5,192 shares owned by The Timothy T. Weglicki Irrevocable Trust dated March 11, 1999 (the ?Trust?), which shares Mr. Weglicki disclaims beneficial ownership of except to the extent of his pecuniary interest therein.
- (2) ABS Partners IV L.L.C., as the general partner (the ?General Partner?) of the Funds and Phillip A. Clough and Timothy T. Weglicki as managers of the General Partner (the ?Managers?), are indirect beneficial owners of the reported securities. The General Partner and each of the Managers disclaim beneficial ownership of the shares owned by the Funds, Timothy T. Weglicki and the Trust except to the extent of their pecuniary interest therein. CONTINUED FOOTNOTE 3.
