- (1) Agreement between the Issuer and Oracle Corporation dated April 19, 2009 (the "Merger Agreement"), the restricted stock units vested in full upon the effectiveness of the merger.
- (2) Pursuant to the Merger Agreement, the restricted stock units were cancelled in exchange for a cash payment of \$372,751.50, which represents \$9.50 for each outstanding unit.
- (3) Pursuant to the Merger Agreement between the Issuer and Oracle Corporation dated April 19, 2009 (the "Merger Agreement"), each share of JAVA common stock will be exchanged for \$9.50 in cash.
- (4) Shares are held directly by the reporting person and his spouse.
