On June 15, 2010, the issuer's board of directors granted a restricted stock award to the reporting person under the issuer's 2007 Equity Incentive Plan. One-half of the award will vest in four equal annual installments beginning on the first anniversary of the date of grant, (1) provided that the reporting person remains employed by the issuer as of each vesting date. One-half of the award will vest on the fourth anniversary of the date of grant, provided that certain corporate performance metrics are achieved and the reporting person remains employed by the issuer as of such vesting date.
