- (1) Mr. Stier is a director, officer and shareholder of Blackbird Corporation, a Florida corporation ("Blackbird"). Blackbird owned 10 million shares of Series A Convertible Preferred Stock of the Issuer (the "Preferred Stock"), which shares represented, on an as-converted basis, 80% of the issued and outstanding shares of Common Stock of the Issuer. Upon the filing of the of the Amended and Restated Certificate of Incorporation of the Issuer on June 7, 2010, the Preferred Stock automatically converted into 520 million shares of Common Stock of the Issuer. Blackbird then distributed the 520 million shares of the Issuer's Common Stock to its existng shareholders, on a pro rata basis, on June 7, 2010.
 - (2) Blackbird distributed 520 million shares of the Issuer's Common Stock owned by Blackbird to its existng shareholders, on a pro rata basis, on June 7, 2010.
 - (3) On October 27, 2010, the Issuer effected a 1-for-30 reverse stock split of its Common Stock, resulting in the reduction of the reporting person's ownership from 17,000,000 shares of Common Stock to 566,667 shares of Common Stock.
