- (1) Pursuant to the issuer's Board of Directors Compensation Plan, the Board of Directors granted \$100,000 of common stock to each non-employee director under the issuer's 2007 Equity Incentive Plan (As Amended and Restated), based on the \$25.65 closing price of the common stock on June 29, 2011, as quoted on the NASDAQ Global Select Market.
- (2) Pursuant to the issuer's Board of Directors Compensation Plan, the reporting person elected to receive \$115,000 of restricted stock issued under the issuer's 2007 Equity Incentive Plan (As Amended and Restated) in lieu of cash compensation. The restricted stock issued to the reporting person is based on the \$25.65 closing price of the issuer's common stock on June 29, 2011, as quoted on the NASDAQ Global Select Market. The restricted stock vests in four equal installments on September 29, 2011, December 29, 2011, March 29, 2012 and June 29, 2012.
- (3) The reporting person is a trustee of the Peter A. Jacobi and Mary Louise Jacobi Living Trust and exercises voting and investment power for the shares beneficially owned by the trust.
- (4) Includes 2,335 shares previously held directly by the reporting person, which were re-registered in the name of the Peter A. Jacobi and Mary Louise Jacobi Living Trust.
