The shares were acquired by Mountain Partners AG, an affiliate of the reporting person, in connection with the acquisition by Bluehill ID AG, a wholly-owned subsidiary of the Issuer, of shares of Payment Solution AG from certain selling shareholders of that company. Mountain Partners AG received 231,667 shares in exchange for its 59,696 shares of Payment Solution AG. See footnote 2.
