- (2) acquired by the director was based on the weighted-average price at which the Company's restricted voting shares traded on the Toronto Stock Exchange on July 27, 2012 and July 30, 2012 (the two trading days prior to the acquisition date), which was \$2.58 (as converted from C\$2.59 using the average of the closing rates of exchange from Reuters on July 27, 2012 and July 30, 2012).
