## Edgar Filing: Lu Yungang - Form 4

- 20,000 stock options with an exercise price of \$3.95 were granted on July 30, 2004. These options vest in two installments of 25% each
- (1) on the first and second anniversary of the grant date, and in eight subsequent quarterly installments of 6.25% each, commencing on October 30, 2006 and ending on July 30, 2008.
  - (2) 12,352 restricted stock units were granted on August 9, 2011 (the "2011 RSUs"). Each 2011 RSU represents a contingent right to receive one share of common stock. The 2011 RSUs vest in two equal installments on the 6-month and 12-month anniversaries of the grant date. The grant of the 2011 RSUs was conditioned on the Reporting Person's cancellation of the 2009 RSUs and 2010 RSUs.
  - (3) 13,394 restricted stock units were granted on August 7, 2012 (the "2012 RSUs"). Each 2012 RSU represents a contingent right to receive one share of common stock. The 2012 RSUs vest in two equal installments on February 7, 2013 and August 7, 2013.
