(5) Previously reported; option granted under 2002 Stock Incentive Plan; exercisable in three equal annual installments beginning January 25, 2003.

(6) Previously reported; represents restricted stock units which vest in three installments beginning in September 2001; upon vesting units are automatically deferred to stock unit account; dividend equivalents are reinvested in deferred stock unit account.

(7) Previously reported; the award vests upon achievement of certain performance criteria and is payable in cash or shares of the Company's Common Stock at the discretion of the Compensation Committee of the Board of Directors; however, if such units do not vest before December 31, 2006, 50% of the performance units will then be payable in shares of the Company's Common Stock provided reporting person is an active employee on that date.

(8) Option granted under 2000 Stock Incentive Plan exercisable in three equal annual installments beginning on February 27, 2004.
