The Restricted Stock Units (RSUs), the conversion of which is reported herein, were granted to the Reporting Person by the issuer as part of equity incentive grants made by the issuer on 02/11/08 utilizing a fair market value (FMV) of a share of the issuer's stock of \$41.62.
