Item 1. Security and Issuer

This Amendment No. 8 to Schedule 13D (“Amendment No. 8”) relates to the Common Stock, \$0.0001 par value per share (the “Common Stock”), of Horizon Pharma, Inc., a Delaware corporation (the “Company”), which has its principal executive offices at 520 Lake Cook Road, Suite 520, Deerfield, Illinois 60015. This Amendment No. 8 amends and supplements, as set forth below, the information contained in items 1, 3, 5 and 6 of the Schedule 13D filed by the Reporting Persons with respect to the Company on August 13, 2012, as amended by Amendment No. 1 thereto filed by the Reporting Persons with respect to the Company on October 25, 2012, as amended by Amendment No. 2 thereto filed by the Reporting Persons with respect to the Company on April 15, 2013, as amended by Amendment No. 3 thereto filed by the Reporting Persons with respect to the Company on May 14, 2013, as amended by Amendment No. 4 thereto filed by the Reporting Persons with respect to the Company on December 13, 2013, as amended by Amendment No. 5 thereto filed by the Reporting Persons with respect to the Company on January 17, 2014, as amended by Amendment No. 6 thereto filed by the Reporting Persons with respect to the Company on February 7, 2014 and as amended by Amendment No. 7 thereto filed by the Reporting Persons with respect to the Company on March 3, 2014 (as so amended, the “Schedule 13D”). All capitalized terms used herein but not defined herein have the meanings set forth in the Schedule 13D. Except as amended by this Amendment No. 8, all information contained in the Schedule 13D is, after reasonable inquiry and to the best of the Reporting Persons’ knowledge and belief, complete and correct as of the date of this Amendment No. 8.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Schedule 13D is hereby amended to read in its entirety as follows:

The total purchase price for the 3,252,626 shares of Common Stock beneficially owned by the Reporting Persons as of March 18, 2014 was approximately \$8,103,226. The source of such funds was the assets of Discovery Equity Partners, including proceeds of margin loans under margin loan facilities maintained in the ordinary course of business by Discovery Equity Partners with a broker on customary terms and conditions. Discovery Equity Partners is the legal owner of all of the Common Stock beneficially owned by Discovery Group and Messrs. Donoghue and Murphy.

Item 5. Interest in Securities of the Issuer

Item 5 of the Schedule 13D is hereby amended to read in its entirety as follows:

The information concerning percentages of ownership set forth below is based on 67,733,417 shares of Common Stock reported outstanding as of March 11, 2014 in the Company’s Annual Report on Form 10-K for the fiscal year ended December 31, 2013.

Discovery Equity Partners beneficially owns 3,252,626 shares of Common Stock as of March 18, 2014, which represents 4.8% of the outstanding Common Stock.

Discovery Group beneficially owns 3,252,626 shares of Common Stock as of March 18, 2014, which represents 4.8% of the outstanding Common Stock.

Mr. Donoghue beneficially owns 3,252,626 shares of Common Stock as of March 18, 2014, which represents 4.8% of the outstanding Common Stock.

Mr. Murphy beneficially owns 3,252,626 shares of Common Stock as of March 18, 2014, which represents 4.8% of the outstanding Common Stock.



Discovery Group is the sole general partner of Discovery Equity Partners. Messrs. Donoghue and Murphy are the sole managing members of Discovery Group. As a consequence, Discovery Group and Messrs. Donoghue and Murphy may be deemed to share beneficial ownership of all of the shares of Common Stock owned by Discovery Equity Partners.

The transactions in Common Stock effected by the Reporting Persons during the past 60 days are set out in Exhibit 1 hereto.

The Reporting Persons ceased to be beneficial owners of more than five percent of the Common Stock on March 17, 2014.

No person other than Discovery Equity Partners is known to any Reporting Person to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, any of the shares of Common Stock reported herein.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

Item 6 of the Schedule 13D is hereby amended to read in its entirety as follows:

There are no contracts, arrangements, understandings or relationships (legal or otherwise) between or among any of the Reporting Persons and any other person with respect to any securities of the Company other than the governing documents of Discovery Group and Discovery Equity Partners, the margin loan facilities referred to under Item 3 above, the Joint Filing Agreement of the Reporting Persons with respect to the Schedule 13D that were included as exhibits thereto, the Joint Filing Agreement of the Reporting Persons with respect to this Amendment No. 8 included as Exhibit 2 to this Amendment No. 8, and the Powers of Attorney granted by Messrs. Donoghue and Murphy with respect to reports under Section 13 of the Securities Exchange Act of 1934, as amended, which Powers of Attorney are included as Exhibit 3 and Exhibit 4, respectively, to this Amendment No. 8.
