The issuer's Supplemental Executive Retirement Plan (the "Plan") was amended in April 2010 to allow participants in the Plan to convert their fully vested, dollar-denominated benefits under the Plan into notional share units. The reporting person delivered a notice of election (1) to convert his vested cash benefit into units on May 6, 2010, and pursuant to the Plan the reporting person's cash balance was converted at the closing price of the issuer's shares on that day as reported by the NYSE. The notional share units will convert to registered shares on a one-for-one basis on the earlier of reporting person's retirement or other termination of employment with the issuer or January 1, 2017.
