The conversion ratio (0, .5, 1.25 or 2.25) ultimately applied to these performance units will be determined based on the company achieving a total shareholder return relative to a specified peer group over the performance period (July 1 2012- December 31, 2014). The units are scheduled to vest on January 1, 2015.
- (3) Each performance unit represents a contingent right to receive 0 to 2 shares. The conversion ratio ultimately applied to these performance units will be determined based on the absolute increase in the issuer's share price over the performance period (July 1, 2012- December 31, 2014). The units are scheduled to vest on January 1, 2015.
